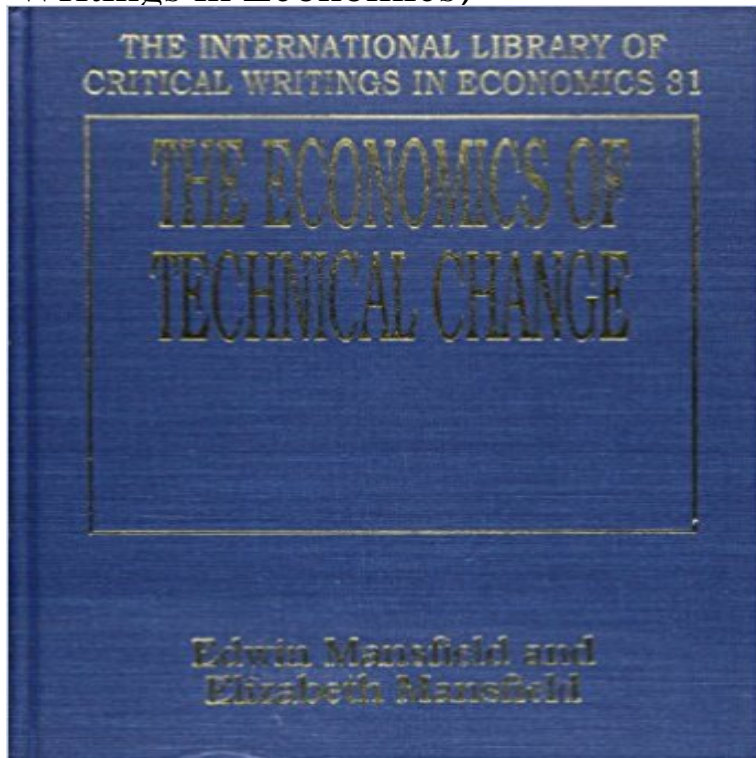


The Economics of Technical Change (International Library of Critical Writings in Economics)
