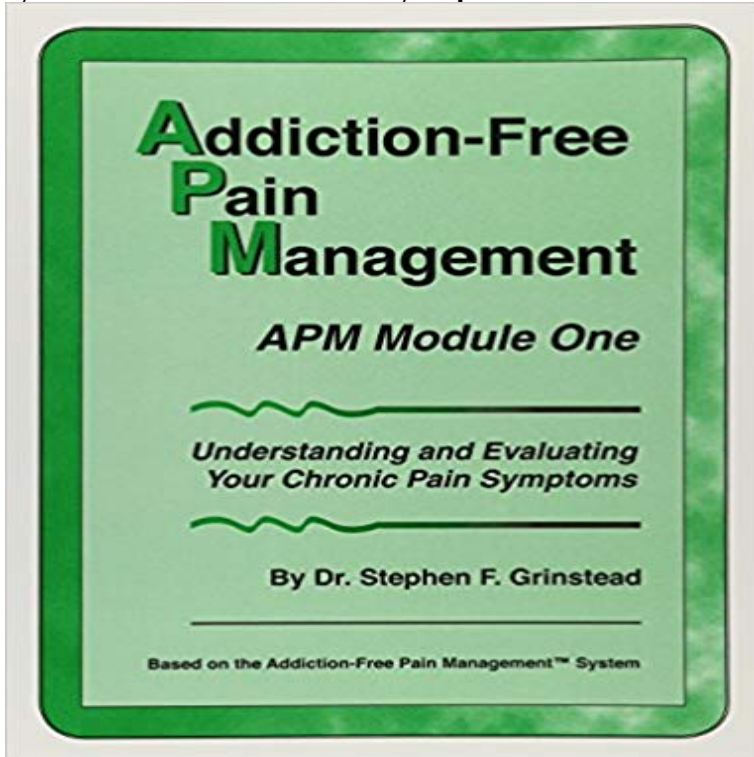


Addiction Pain Management Module 1 Understanding and Evaluating your chronic Pain Symptoms
