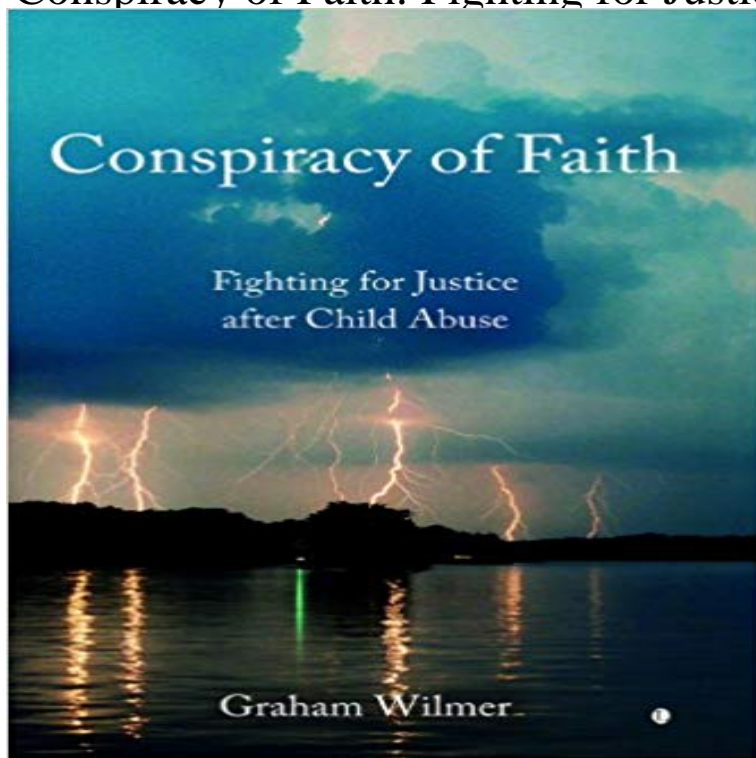


Conspiracy of Faith: Fighting for Justice after Child Abuse
