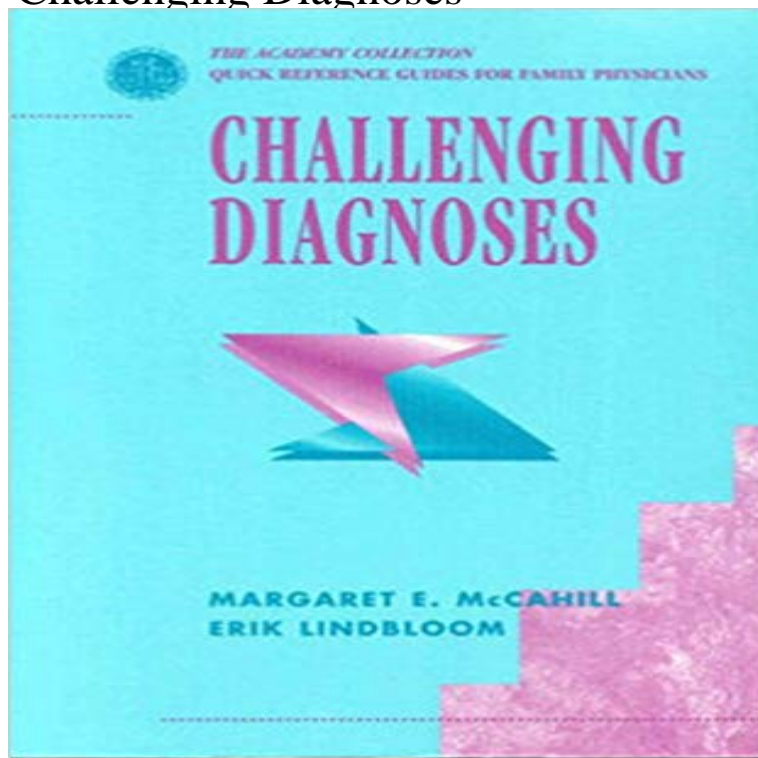


## Challenging Diagnoses
