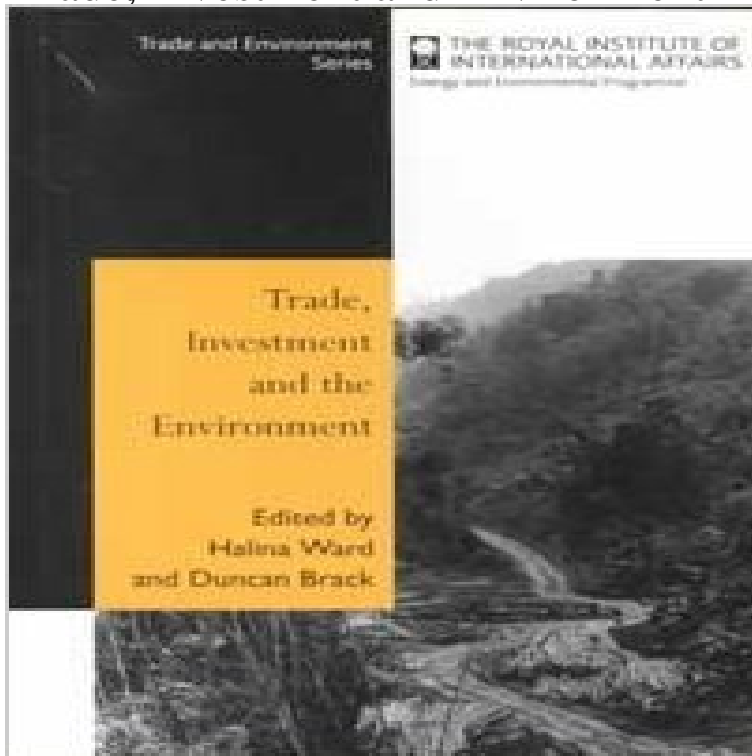


Trade, Investment and Environment
